



## Minutes COP Committee

July 25, 2012

Meeting commenced at 7:00 pm.

### Vial of Life

- The sub-committee of Glenna, Linda, Ted, Karen and Heather had met and done a lot of work.
- **Letter:** Glenna handed out a copy of the letter that would accompany the vial.
- The only change recommended was that they specify what exactly the “registry” would be composed of – only name and contact information, no health information.
- **Insert:** There was discussion on the insert.
- The only change suggested was that the location of the medicine be indicated on the form (i.e. medicine cabinet, kitchen cupboard).
- **Trademark:** Glenna had noted that “Vial of Life” was trademarked and should be indicated as such.
- **Magnets:** We had received an excellent quote from Originals and Linda has already placed the order for the magnets.
- EMS Guelph-Wellington is sharing the cost with us.
- **Packaging:** It was decided to simply place the insert in the vial and attach the letter and magnet to the outside using an elastic band.
- **Vials:** 500 vials from University Centre Pharmacy were on hand.
- Susan would pick up the vials from Carlisle Pharmacy soon.
- **Assembly:** Susan has the names of students who will put the vials together.
- Glenna will contact Bob Gordon to see if they can use the Fire Hall.
- **Launch:** This will take place at the Fall Fair on September 8<sup>th</sup>.
- Heather had volunteered to do a poster for the Fair for Vial of Life.
- The display board would also feature our continued commitment to Road Watch.
- A voluntary registry will be kept of people receiving the vials at the Fair – and anywhere else the vials are handed out.
- It was suggested that we get balloons with Vial of Life on them as well as a cake for the launch.
- Karen would be holding a workshop for Seniors soon after the Fair and would be discussing the Vial of Life.
- We would also have a booth at the market on September 22, 2012.
- People to man the various booths will be sorted out at the August 15<sup>th</sup> meeting.

- **Council Presentation:** Wayne had suggested that the COP Committee make a presentation to Council on the Vial of Life.
- Glenna will be making a presentation on August 15<sup>th</sup>.

### **Morriston Update**

- Sandra had spoken to Sgt. Bob Uridil.
- The OPP would not be sharing specific data obtained from the sign with the public as it was purely an information tool for the OPP to plan their operations.
- He did provide the information that there were some speeders but not enough to cause concern and he was more concerned about the volume of traffic.
- Susan noted that a portion of the highway through Morriston had been repaved.
- In a letter to the MTO from Bill K., he had expressed his thanks and noted that “the trucks would not vibrate the buildings as much now”.
- In his latest e-mail to MTO, Bill had thanked them for agreeing to some traffic calming measures.
- Susan will contact Sarah Wilhelm at the County to get further information.
- Paul expressed concern that we, as a COP Committee, were not being allowed to get the data from the speed monitor.
- This information is sometimes critical in our dealings with the MTO and County.
- Sandra will write to Acting Inspector Susan Gray and ask for clarification on this issue..

### **Use of Our Speed Sign at Puslinch Lake and 911 Problem**

- Glenna commented that the sign had been up in Arkell for one day as well.
- Part of Arkell Road is now 70kph but it is still 50kph in the hamlet.
- The OPP were now using the radar gun and they were “pulling them in like flies”!
- Doug had only been able to get the monitor (shared with Guelph-Eramosa) for a week.
- Heather had manned the monitor as it does not automatically record speeds.
- Overall she felt it had been a worthwhile exercise as it showed drivers that they were speeding though it would have been nice to have had it for another week.
- Heather had heard nothing further on the 911 issue of not being able to locate certain addresses around Puslinch Lake.
- She had contacted the dispatch centre and they had suggested that she do a trial.
- They will still have to send someone out but it will be a good test to see if they can find her.

### **SCC**

- Centre Wellington Councillor Gary Williamson and S/Sgt. Jack Hungen are taking over the running of this Committee.
- Susan had been informed of this at Council by the Mayor.
- Glenna noted that there is a meeting of all COP/SCC Committees on September 5<sup>th</sup>.
- Susan will attend and state our position on the situation: that we are too well established as the COP Committee to change our name and our focus is the community, not County-wide. We would work with the SCC but that we will continue as the COP Committee.
- Susan will contact the Mayor to see if he has any information on the SCC that has come up at County.
