BUSINESS ARISING FROM MINUTES:

i) Flooring – June went to Bigelow. She looked at heavy duty commercial vinyl that looks like wood (20 year warranty). Sarmazian – June did not care their product; went to see flooring at Woodlawn Bowl and it did not stand up well; vinyl flooring installed via planks. Milton Flooring is commercial grade flooring; engineered wood; this flooring can be refinished. Broderick's is commercial product but could not be sanded.

Refinishing would cost \$7500.00 plus maintenance costs of approximately \$2000.00 per year.

Wait for Bigelow to get June a place to look at before we decide. Another floor that has been down for six years (Milton) will also be looked at.

The floor looks old - is it a deterrent. We need something that is water and soil tolerant. It is very dated.

June, Tom and Cam will look at a couple of the flooring places that have been installed. We are looking at up-dating the rest of the hall and we should be looking at new instead of refinishing.

- iii) Roof Work Audrey spoke to the Demikon workers and they have agreed to repair the drywall in the cloak room. Have we followed up on the roof work and make sure that the work that was requested was done.
- iv) Minor Soccer AGM Margaret Hauwert attended the meeting and gave the Committee information from that meeting as follows:

 - Margaret mentioned that the netting needs to come down and that job have been done
 - Soccer asked about the new property
