Hello Donna,

After extensive discussions and negotiations with our landlord, they have accepted revising the proposed antenna location to a distance of 1x tower height from the northern property line (70m). Please see attached. In our opinion, this fully addresses the Bennett's expressed fear of the tower collapsing onto their property, and places the antenna over 430 metres from the Bennett house. Please be advised that this concludes our reconsideration any potential relocation of the tower on the property.

We respectfully request that Council reconsider its previously expressed opposition to the proposed installation and provide concurrence for the proposed installation at the next available Council date.

Also, we understand that additional correspondence has been received by the Town regarding this proposal. We ask that it be forwarded to our attention so that we might provide it to Industry Canada and include it in our files.

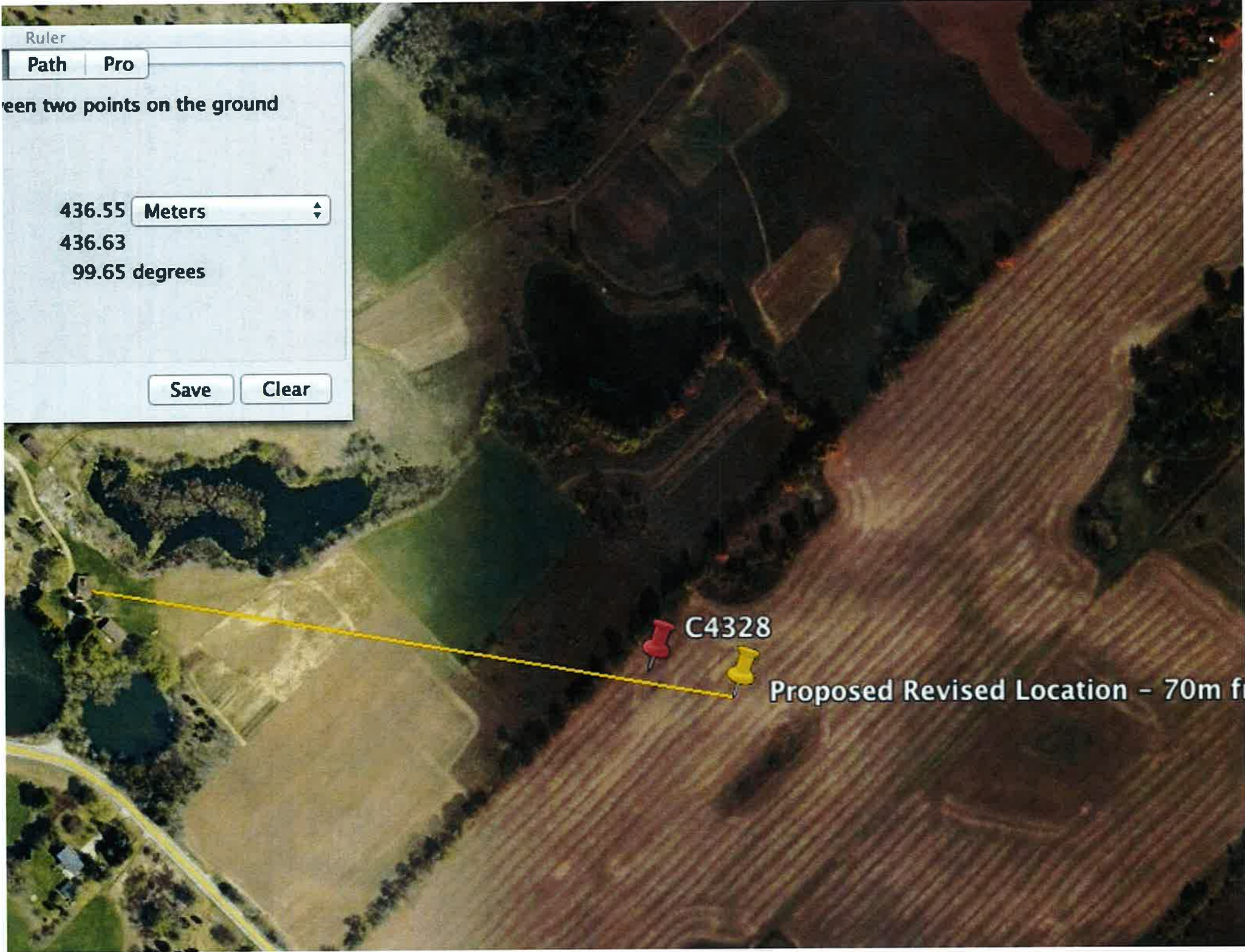

As longstanding residents of Puslinch, we wish to express support for the cell phone tower that Rogers Communications is proposing at 4555 Victoria Rd. S. (RR#1).

One would expect that at our location between the City of Guelph and Highway 401, there would be cell phone service. However, this service is virtually non-existent in much of our residence, and I am sure that many of our Puslinch neighbours are experiencing similarly poor levels of wireless service. The lack of signal makes it difficult to conduct business at home, and is a potential safety issue in the event of an emergency situation.

We understand that there is a risk that the tower may not go ahead because of an area resident who is opposed to its location.

We thought you should be aware that there is support for the tower, and that we believe its impact will be positive and for the greater good of Puslinch.
