

THE

The City of Hamilton has undertaken a Subwatershed Study in support of the Secondary Planning process for the Stoney Creek Urban Boundary Expansion (SCUBE) Area. subwatershed study area consists of the drainage boundaries for the streams which drain proposed future development areas within the SCUBE East and SCUBE West lands. This encompasses the lands between Fruitland Road and the City boundary, and from Lake Ontario to just above the Niagara Escarpment.



The study was undertaken in three phases:

- Phase 1 of the study investigated and inventoried the natural resources of the study area to identify environmental constraints and opportunities.
- Phase 2 of the study evaluated future landuse impacts, and developed a management strategy comprised of recommended works and measures to address stormwater management and the maintenance, protection and enhancement of the study area's significant natural heritage features and ecological functions.
- Phase 3 of the study developed an implementation plan to guide future work by the City of Hamilton and development proponents.

THE PROCESS

The study was undertaken in accordance with Section A.2.7 Master Plans as defined in the Municipal Engineers Association's *Municipal Class Environmental Assessment* document (October 2000, as amended in 2007 & 2011) and satisfies Phases 1 and 2 of the planning and design process. The study findings were presented at two Public Information Centres (PICs) held in November 2008 and June 2010. There is an opportunity at any time during the study process for interested persons to review outstanding issues and bring concerns to the attention of the Project Managers.

PROJECT REPORTS AVAILABLE FOR REVIEW

The study findings were documented in three reports:

- The "Stoney Creek Urban Boundary Expansion (SCUBE) West Subwatershed Study" report documents the Phase 1 and Phase 2 components for the study area lands between Fruitland Road and McNeilly Road;
- The "Stoney Creek Urban Boundary Expansion Area (SCUBE) East Subwatershed Study" report documents the Phase 1 and Phase 2 components for the study area lands between McNeilly Road and the eastern City boundary; and
- The "SCUBE Subwatershed Study Phase 3: Implementation" report documents the Phase 3 recommendations for both the SCUBE West and SCUBE East study areas.

Hard copies of the above reports which document the planning process undertaken and the conclusions reached will be placed on public record for a minimum 45 day review period in accordance with the Municipal Class EA, outlining the EA process, study details, the proposed alternatives, evaluation criteria, public consultation and methodology. The reports are available for public review at the following location:

- 2. Arrange a meeting with the above City staff member if you have significant concerns that may require more detailed explanation.
- 3. If you raise major concerns, the City will attempt to negotiate a resolution of the issues. A mutually acceptable time period for this negotiation will be set. If the issues remain unresolved, you may request the Minister of the Environment, by order, to require the City to comply with Part II of the Environmental Assessment Act (EAA).

Requests to comply with part II of the EAA must be submitted in writing to the Minister of the Environment within the 45 day review period (by September 16, 2013).
