**BY-LAW NUMBER 2014-XX**

A By-law to amend By-law 74/13 being a By-law to  
Impose fees or charges with respect to services or activities  
provided, related costs payable, and for the use of its property

**WHEREAS** Council passed By-law 74/13 on December 4, 2013; and

**WHEREAS** Section 391(1) of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, a municipality may pass a By-law imposing fees or charges for services or activities provided or done by or on behalf of it, for costs payable by it for services or activities provided or done by or on behalf of any other municipality, and for the use of its property under its control; and

**WHEREAS** Section 7(1) of the Building Code Act, 1992, S.O. 1992, c. 23, as amended provides that the Council of municipality may pass By-laws imposing fees and charges; and

**WHEREAS** Schedule "F" of By-law 74/13 requires a provision to incorporate a Reproduction of Drawings fee of \$50 (net of HST) in Schedule "F" of By-law 74/13;

**WHEREAS** Schedule "G" of By-law 74/13 requires a provision to incorporate a fee of \$0.06 per tonne of fill as part of a Site Alteration Permit in Schedule "G" of By-law 74/13;

**NOW THEREFORE** the Council of the Corporation of the Township of Puslinch enacts as follows:

1. That Schedule "F" to By-law 74/13 incorporates a Reproduction of Drawings fee of \$50 (net of HST).
2. That Schedule "G" to By-law 74/13 incorporates a fee of \$0.06 per tonne of fill as part of a Site Alteration Permit.
