**BY-LAW NO. 2013-XXX**

A by-law to establish advance voting dates for the 2014  
Municipal Election.

WHEREAS Section 43(1) of the *Municipal Elections Act, 1996*, as amended, provides that, at least 30 days before Voting Day, the Council of a local municipality shall pass a by-law establishing,

- (a) one or more dates for an advance vote; and
- (b) the hours during which voting places shall be open on the date or dates; and

WHEREAS the Council of The Corporation of the Township of Puslinch deems it appropriate to pass an Advance Voting Date By-law in accordance with the legislation;

NOW THEREFORE the Council of The Corporation of the Township of Puslinch HEREBY ENACTS AS FOLLOWS:

- 1. That an advance voting date and hours shall be held in the 2014 municipal election as follows:

Saturday, October 18, 2014 from 9:00 a.m. to 6:00 p.m.

**BY-LAW NO. 2013-XXX**

A by-law to establish reduced hours of voting in long term care facilities for the 2014 Municipal Election.

WHEREAS Section 46(3) of the *Municipal Elections Act, 1996*, as amended, provides that, the Council of a local municipality may pass a by-law with respect to a voting place described in subsection 45(7) that is only for the use of residents of the institution or retirement home, providing for reduced opening hours; and

WHEREAS the Council of The Corporation of the Township of Puslinch deems it appropriate to establish reduced polling hours for the Morriston Park Nursing Home;

NOW THEREFORE the Council of The Corporation of the Township of Puslinch HEREBY ENACTS AS FOLLOWS:

1. That reduced voting hours for institutions and retirement homes in the Township of Puslinch shall be as follows:

**THE CORPORATION OF THE TOWNSHIP OF PUSLINCH**

**BY-LAW NUMBER xx/13**

Being a by-law to confirm the proceedings of the Council of the Corporation of the Township of Puslinch at its meeting held on December 18, 2013.

**WHEREAS** by Section 5 of the *Municipal Act, 2001, S.O. 2001, c.25* the powers of a municipal corporation are to be exercised by its Council;

**AND WHEREAS** by Section 5, Subsection (3) of the *Municipal Act*, a municipal power including a municipality's capacity, rights, powers and privileges under section 8, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

**AND WHEREAS** it is deemed expedient that the proceedings of the Council of the Corporation of the Township of Puslinch at its meeting held December 18, 2013 be confirmed and adopted by By-law;

**NOW THEREFORE** the Council of the Corporation of the Township of Puslinch hereby enacts as follows:

- 1) The action of the Council of the Corporation of the Township of Puslinch, in respect of each recommendation contained in the reports of the Committees and each motion and resolution passed and other action taken by the Council at said meeting are hereby adopted and confirmed.
- 2) The Head of Council and proper official of the Corporation are hereby authorized and directed to do all things necessary to give effect to the said action of the Council.
- 3) The Head of Council and the Clerk are hereby authorized and directed to execute all documents required by statute to be executed by them, as may be necessary in that behalf and the Clerk authorized and directed to affix the seal of the said Corporation to all such documents.
