BY-LAW NUMBER 68/14

Being a by-law to authorize the entering into an Agreement with The Corporation of the Township of Guelph Eramosa regarding an Automatic Aid Agreement.

WHEREAS the *Municipal Act*, S.O. 2001, c.25 authorizes a municipality to enter into Agreements;

AND WHEREAS the Council for the Corporation of the Township of Puslinch deems it appropriate to enter into an Agreement with The Corporation of the Township of Guelph Eramosa regarding an Automatic Aid Agreement in respect of certain initial responses to certain fires in certain situations in certain geographical areas;

NOW THEREFORE the Corporation of the Township of Puslinch hereby enacts as follows:

BEING A BY-LAW TO AUTHORIZE THE ENTERING INTO OF A SITE ALTERATION AGREEMENT WITH WYNDHAM STREET INVESTMENTS INC. AND TO REPEAL BY-LAW 61/14

WHEREAS the *Municipal Act*, S.O. 2001, c.25 authorizes a municipality to enter into agreements;

AND WHEREAS the Council for the Corporation of the Township of Puslinch deems it expedient to enter into a Site Alteration Agreement with Wyndham Street Investments Inc.;

NOW THEREFORE the Council of the Corporation of the Township of Puslinch enacts as follows:

BEING A BY-LAW TO AUTHORIZE THE ENTERING INTO OF A CONDITIONAL BUILDING PERMIT AGREEMENT WITH JEFFREY GORDON BORN AND VICKI MARGUERITE DICKSON

WHEREAS the *Building Code Act 1992*, S.O. 1992, c.23 authorizes a municipality to enter into agreements;

THE CORPORATION OF THE TOWNSHIP OF PUSLINCH

BY-LAW NUMBER 71/14

Being a by-law to confirm the proceedings of the Council of the Corporation of the Township of Puslinch at its meeting held on November 5, 2014.

WHEREAS by Section 5 of the *Municipal Act, 2001, S.O. 2001, c.25* the powers of a municipal corporation are to be exercised by its Council;

AND WHEREAS by Section 5, Subsection (3) of the *Municipal Act*, a municipal power including a municipality's capacity, rights, powers and privileges under section 8, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

AND WHEREAS it is deemed expedient that the proceedings of the Council of the Corporation of the Township of Puslinch at its meeting held November 5, 2014 be confirmed and adopted by By-law;

NOW THEREFORE the Council of the Corporation of the Township of Puslinch hereby enacts as follows:

- 1) The action of the Council of the Corporation of the Township of Puslinch, in respect of each recommendation contained in the reports of the Committees and each motion and resolution passed and other action taken by the Council at said meeting are hereby adopted and confirmed.
- 2) The Head of Council and proper official of the Corporation are hereby authorized and directed to do all things necessary to give effect to the said action of the Council.
- 3) The Head of Council and the Clerk are hereby authorized and directed to execute all documents required by statute to be executed by them, as may be necessary in that behalf and the Clerk authorized and directed to affix the seal of the said Corporation to all such documents.
