Being a by-law to authorize the entering

**WHEREAS** the Municipal Act, S.O. 2001, c. 25, authorizes a municipality to enter into agreements;

**AND WHEREAS** Council deems it expedient to enter into an agreement with the Corporation of the Town of Erin regarding the provision of Chief Building Official services as may be required from time to time;

**NOW THEREFORE** the Council of the Corporation of the Township of Puslinch enacts as follows:

1. That the Corporation of the Township of Puslinch hereby authorizes the entering into an agreement dated the 19<sup>th</sup> day of February, 2014 with the Corporation of the Town of Erin for the provision of Chief Building Official services as may be required by the respective municipalities from time to time.
2. That the Mayor and Clerk are hereby authorized to execute the said Agreement.

**BY-LAW NUMBER XX/14**

Being a by-law to appoint Robert Kelly as a Municipal Law Enforcement Officer for the Corporation of the Township of Puslinch and to repeal By-law 27/13

**WHEREAS** Section 15 of the Police Services Act, R.S.O. 1990, c. 15, authorizes a Council to pass a by-law to appoint a Municipal Law Enforcement Officer;

**AND WHEREAS** Section 227 of the Municipal Act, S.O. 2001, c. 25, authorizes a Council to pass a by-law to appoint such officers and employees as may be necessary for the purposes of the Corporation, for carrying into effect the provisions of any by-law of Council;

**NOW THEREFORE** the Council of the Corporation of the Township of Puslinch enacts as follows:

1. That Robert Kelly is hereby appointed as a Municipal Law Enforcement Officer and Peace Officer for the purpose of enforcing the municipal by-laws.
2. That By-law 27/13 is hereby repealed.

Being a by-law to appoint Andrew Hartholt and Michael Newark as a Chief Building Official for the Corporation of the Township of Puslinch in the absence Township's Chief Building Official and to repeal By-laws 43/05, 39/00, 38/2000 and 11/99

**WHEREAS** Section 3 of the Building Code Act, S.O. 1992, c. 23, requires a municipality to appoint a Chief Building Official and such inspectors as are necessary for the enforcement of the Act; and

**WHEREAS** the Corporation of the Town of Erin and the Corporation of the Township of Puslinch have entered into an agreement for the provision of providing Chief Building Official Services to each other as may be required from time to time; and

**WHEREAS** the Corporation of the Township of Puslinch has engaged the services of Michael Newark, Chief Building Official of Guelph-Eramosa as required from time to time;

**NOW THEREFORE** the Council of the Corporation of the Township of Puslinch enacts as follows:

1. That Andrew Hartholt and Michael Newark are hereby appointed as a Chief Building Official as required by the Township from time to time.
2. That By-laws 43/05, 39/00, 38/2000 and 11/99 are hereby repealed.

**THE CORPORATION OF THE TOWNSHIP OF PUSLINCH**

**BY-LAW NUMBER OXX/14**

Being a by-law to confirm the proceedings of the Council of the Corporation of the Township of Puslinch at its meeting held on February 19, 2014.

**WHEREAS** by Section 5 of the *Municipal Act, 2001, S.O. 2001, c.25* the powers of a municipal corporation are to be exercised by its Council;

**AND WHEREAS** by Section 5, Subsection (3) of the *Municipal Act*, a municipal power including a municipality's capacity, rights, powers and privileges under section 8, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

**AND WHEREAS** it is deemed expedient that the proceedings of the Council of the Corporation of the Township of Puslinch at its meeting held February 19, 2014 be confirmed and adopted by By-law;

**NOW THEREFORE** the Council of the Corporation of the Township of Puslinch hereby enacts as follows:

- 1) The action of the Council of the Corporation of the Township of Puslinch, in respect of each recommendation contained in the reports of the Committees and each motion and resolution passed and other action taken by the Council at said meeting are hereby adopted and confirmed.
- 2) The Head of Council and proper official of the Corporation are hereby authorized and directed to do all things necessary to give effect to the said action of the Council.
- 3) The Head of Council and the Clerk are hereby authorized and directed to execute all documents required by statute to be executed by them, as may be necessary in that behalf and the Clerk authorized and directed to affix the seal of the said Corporation to all such documents.
