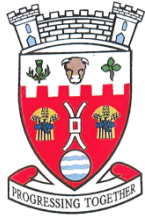

6. **DISCUSSION REGARDING HERITAGE INFORMATION ON THE TOWNSHIP OF PUSLINCH WEBSITE.**

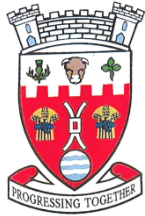
The Committee was given a list of Heritage Websites to review.
