This Report summarizes the results of the groundwater monitoring program for the CBM Puslinch Pit as per the Hydrogeological Recommendations of the current Pit License.

Below Water Table Extraction

CBM reports that no below water gravel extraction occurred at the site from November 2013 to the monitoring event in March 2014.

Water Level Monitoring and Threshold Status

Due to temperatures and heavy snow cover, monitoring access this winter has been reduced. In addition, ponds have remained frozen. The reported October to March water level measurements, compared to threshold values, are summarized as follows:

As indicated by the measurements, there were no threshold exceedances observed and no Action Response from November 2013 to March 2014.

There is no current "Declared Low Water Condition" reported for Mill Creek and streamflow rates are currently classified to be within "Normal Summer Lowflow", as shown on the GRCA Low Water Response web site. Actual streamflows are currently relatively high.

The monitoring program is proceeding as per the Licence requirements, and monthly summaries will continue to be provided during the operational season.

The application is for a Category 3, Class "A" licence, pit above the water table for 51.16 hectares of land located on the subject property located in the Township of Guelph-Eramosa. The application is for a new pit with a proposed annual tonnage limit of 650,000 tonnes.

The Ministry of Natural Resources has determined the application package to be complete on April 22, 2014 and has given the applicant permission to continue with the public notification and consultation process described in the provincial standards. The 45 day notification period will begin on May 20, 2014.

After July 4, 2014, it will be deemed that there are no objections to the licence application.

PUSLINCH HISTORICAL SOCIETY Presidents Report - Annual Meeting - April 8 2014

Our membership stands at about 30, since our last annual meeting. Some of our members are out of town, a reflection of the success of our website. As well as our paid membership, we have a mailing list of almost 150 "friends of the society". Our membership chairman will report the current standing.

The events we held in the past year were generally well received. We held another Spirit Walk at Crown Cemetery in June 2013 profiling five people buried there.

Horse-logging was the subject of our October 2013 meeting. Local artist Joan Hug-Valeriote's video of Greg Parker and his team of Belgian horses attracted several new faces to our meeting. Mr. Parker was on hand for the event.

At our November meeting, Larry Cotton, author of "Whiskey and Wickedness-Wellington – Waterloo Counties" entertained us with anecdotes from the 19th century illustrating the effect booze had on life then.

Dr. Elizabeth Ritchie from University of the Highlands in Scotland was our guest in February 2014. She discussed the experiences of Scottish pioneer woman in Upper Canada.

Our archives are open on Saturdays, or by appointment other times. We have over 4000 items in the archives, and this past year a database was created. All our books have been indexed now, and work is underway on the material in the filing cabinets. We thank another unpaid volunteer for this big job, who has worked with Betty Ferguson, our archives staff person, for several months.

We continue to add appropriate material to the archives; most of it is by donation, and we thank our donors.

We continue to enjoy the support of Puslinch Council. We are members of Ontario Historical Society, the umbrella society of the province, and Wellington County Historical Society.

- In 2014 our speakers will be as follows:
- May 13 Edith George, Advisor to the Ontario Urban Forest Council: "Securing the Future of Heritage Trees"
- June 23 Spirit Walk in Crown Cemetery, the theme will be tradespeople; we will profile a millwright, a cooper, a miller, a stonemason and a blacksmith, all buried in Crown cemetery.
- Sept 13 Prof. Don Smith, author of "Mississauga Portraits-Ojibwe Voices from 19th Century Canada" will speak on relations between Aboriginals and early European settlers on the north Shore of Lake Ontario.
- Nov 18 Paul O'Hara, Botanist, owner of Blue Oak Nurseries, on "Indian trail marker trees".

In summary, I feel that the year was successful. Although our society is not large, we have a significant profile in the township, and indeed, internationally. I thank all the volunteers for their commitment and enthusiasm, and the library staff for their ongoing co-operation.

The Puslinch Youth Group is now under the leadership of Sarah McCaig and Sarah Tosh. We are volunteering our time every other Monday night to run events for kids in the community. We host our events at Duff's church as they provide us with guidance, but we are not limited to the church. Our main endeavor is to allow the community to become aware of our existence. We want to bring the youth of the community together in an open friendly and safe environment. Our goal is to provide a place for youth to meet new people and become more involved in the township. We want to show youth how they can give back to their community.

Our goal is to run a fundraiser by creating a small-scale carnival for the community. This would be organized and ran by the Puslinch Youth Group in conjunction with the Puslinch Optimist possibly. The hope is to raise money to be donated to youth housing in Guelph, families or youth in need from our own community, or needs which may exist at Aberfoyle School. (To be determined upon approval.)

The event would consist of carnival attractions such as, carnival games. This would include a dress up station, face painting, plunger toss, clowns, etc. We also hope to have a petting zoo consisting of local farm animals. There may possibly be tractor or horse rides provided if someone donates this to the cause. There may be possibly a home run derby organized or a baseball game. We do not want to have large-scale rides such as a ferris wheel. We are more looking to have small jumping castles for example. The goal is for all the venues to be donated and others constructed by the youth group.

The intention is to run this as a free admission event. Some venues may require payment to play such as the dunk tank but most games and venues would be free. (Again

this is to be determined). There will be booths set up and people collecting "free-will" donations towards the chosen charities.

What we are asking of the Township is permission to use the tractor pull area, the horse paddock area for events and the backfield for parking if necessary. We would also like use of a ball diamond but not necessarily for the whole day. (Perhaps 1-2 hours.) The date we are considering is Saturday June 14, 2014. The event would run from 10 am – 3pm. We would probably need access from 7am until 5 pm to ensure proper set up and clean up.

We would greatly appreciate if the Township would be extremely gracious and permit us to use the mentioned grounds for free or at a reduced rate since this is an event for the community. We understand if this is not possible but we still would like permission to rent these grounds and were wondering about the cost. Our other option is could we hold this event at Morriston Meadows if the Community Centre grounds are unavailable and what the cost for this site would be? Another concern is if we have use of this ground does the Township's liability insurance cover the rental for such an event?
