Whereas the cost of liability insurance has sky rocketed by 22.2% from 2007 to 2011 with some municipalities reporting increases of up to 50%; and

Whereas an AMO report predicts that unless change is made, insurance related costs will increase further to \$180 million by 2015, an additional 16%; and

Whereas municipalities are now paying up to \$37.56 per capita for insurance costs and this amount will continue to accelerate; and

Whereas Frank Cowan Company (representing 144 municipalities), the Region of Durham, County of Brant, the Regional Municipality of Waterloo, the Municipality of Chatham-Kent and the Ontario Municipal Insurance Exchange (representing 23 municipalities) and many others endorse a call to action; and

Whereas the current situation is not sustainable and a long-term solution is required that is beneficial to all parties; and

Whereas a long term solution can be achieved by a careful review and the adoption of one or more of the following solutions:

- Capping awards
- Developing a Provincial fund to assist with paying large claims
- Utilizing tribunals to streamline the Court system



- Structured settlements that provide awards over time
- Immunities for municipalities; and

Whereas these remedies are already in place in other jurisdictions;

Now therefore the Township of Puslinch supports careful consideration of these options along with the goal of developing a stable, sustainable and equitable solution that will lead to a balanced approach that all stakeholders require; and

That a copy of this resolution be sent to AMO, Frank Cowan Company Limited and Ted Arnott, MPP.

Waterloo-Wellington Community Futures

Councillor Fielding advised Council that she attended the Annual General Meeting on September 11, 2013. She advised Council that the program has been in operation for 10 years and that during this period of time there have been 274 requests for assistance with over 12.5 million of assistance provided and 7.3 million of which has been repaid within the last 9 years. She advised Council that this has been a very successful program with many of the businesses that received assistance becoming extremely successful.

Guelph Water Supply Master Plan Update

Councillor Stokley advised that he attended a meeting at the City of Guelph on September 17, 2013, with respect to the updates to the City of Guelph's 2007 Water Supply Master Plan. Councillor Stokely advised Council that the goals of the group are to look at both sources and conservation of water.

Fire and Rescue Services Committee Meeting

Councillor Schmidt provided Council with a summary of the items discussed at the September 18, 2013 meeting. Councillor Schmidt advised Council that the committee is conducting a review of the current fees charged by the Department so it more accurately
