In this Report staff advised Council that at the September 24, 2013, Recreation Committee meeting the members of the committee made a recommended that a community assessment include obtaining community feedback on changing the name of the Community Centre and that staff will provide its recommendation regarding the content of the Community Assessment and a survey regarding a name change during 2014 budget presentations.
