SUBJECT:	Update – In-Kind Bookings – Puslinch Community Centre

## RECOMMENDATIONS

That Report ADM-2014-010 regarding Update – In-Kind Bookings – Puslinch Community Centre be received; and

That the matter of a reduction or waiving of fees to specific groups and organizations be reviewed as part of the annual review of the Township's User Fee By-Law.

## PURPOSE

The purpose of this Report is to provide Council with the requested financial information including 2013 Financial Statements and 2014 Budgets received from the various Service, Community Groups, Clubs, Daycare and Playgroups receiving in-kind bookings at the Puslinch Community Centre.

## DISCUSSION

At the February 5, 2014, Operating Budget Meeting, Council received report FIN-2014-006–2014 Grant Requests. Before, consideration of the various grant requests, Council requested that staff obtain financial information from the various service, community groups, clubs, daycare and playgroup groups receiving in-kind bookings at the Puslinch Community Centre.

Staff provided correspondence only to those groups which staff had indicated in Report ADM-2013-011, attached as **Schedule** "**A**", had received in-kind bookings at the Puslinch Community Center and had not previously submitted financial information as part of the Township's grant application process.

#### RECOMMENDATIONS

The Report ADM-2013-011 regarding in-kind bookings at Township Facilities be received; and

That commencing January 1, 2014, any community group meetings utilizing Township facilities be accommodated at the Puslinch Community Centre.

#### DISCUSSION

#### Purpose Purpose

The purpose of this Report is provide Council with information regarding in-kind bookings at the various Township Facilities. Grants provided by the Township is discussed in Report FIN-2013-005.

#### Background

The Township has various facilities for daily rental. As requested by Council during the 2013 budget deliberations and in preparation of the 2014 User Fees By-Law, staff has comprised a list of service groups, community groups and clubs which receive in-kind bookings at the various Township Facilities.

#### Service Community Groups and Clubs

Attached to this Report as **Schedule** "A" is a chart which provides details regarding the user group, event, facility used, duration of event and revenues which were waived for the rental of the facility.

#### **Daycare and Playgroup**

On August 14, 2013, Township Council received reports:

- REC-2013-002-regarding the Agreement with Whistle Stop Daycare; and
- REC-2013-003- regarding the Agreement with Guelph Community Health Centre – for daycare services - Puslinch Community Centre – 23 Brock Road S;

The Township has entered into Agreements for the 2013/2014 season with both Whistle Stop Daycare and Guelph Community Health Centre. No compensation is paid for the rental of the Township facilities. Staff indicated in the August 14, 2013 reports that they would be providing a further report summarizing the various agreements or arrangements where there is minimal monetary consideration and grants issued by the Township.

Attached to this Report as **Schedule "B"** is a chart which provides details regarding the Whistle Stop Daycare and Guelph Community Health Centre (playgroup) of the township's facilities.

#### **Storage Facilities**

This report does not include information on the various groups using the various Township facilities for storage. The Township does not have a fee associated with storage.

#### **Organized Sports Associations/Groups**

This report does not address the fees charged and the recovery of costs to the Township for the use of outdoor facilities such as soccer fields and baseball diamonds.

#### **Puslinch Historical Society**

The Township has entered into a 5 year Lease Agreement from September 16, 2011 to September 16, 2016, with the County of Wellington to pay the costs associated with the rental of office space at the Puslinch County Library. The costs associated with this lease amounts to \$5,000 per annum.

#### **Discount to Township Residents**

As of January 1, 2012, the Township moved from a resident/non-resident rate fee structure to one rate in its User Fee By-Law. In an effort to encourage Puslinch Resident's to book the Township's facilities a 13% resident discount has been offered when requested to Puslinch Residents who book the facilities.

Attached to this Report as **Schedule "C"** is a chart which shows the resident discount amounts waived in 2012 and as of September 30, 2013.

#### **Financial Implications**

Based on the Townships 2013 User Fee By-Law the total annual financial impact to the Township is \$29,218.37.
