





- One-time bookings: Payment required within seven days of contract creation.
- Recurring bookings throughout the year: Payment required on a quarterly basis. The first payment required within seven days of contract creation.
 Future payments required quarterly prior to the scheduled rentals.
- Recurring seasonal bookings: Payment required in two instalments. The first payment required within seven days of contract creation. The second payment required halfway through the season; and

That the Township work with the minor sports leagues that currently pay on a per resident and per non-resident basis to transition them to the Township's booking and facility contract process in accordance with the proposed User Fee By-law; and

That the adult baseball leagues that previously paid on a per resident and per non-resident basis obtain the reduced rate for 2018 only and that the adult leagues pay the rental fees based on usage at the full rate effective January 1, 2019; and

That the Township's agreement with the Calvary Baptist Church be terminated effective December 31, 2017 at the full rate of \$26 with the reduced rate percentage as determined by Council and that the Puslinch Minor Soccer Club enter into a new agreement directly with the Calvary Baptist Church; and

That Township staff bring forward a use/cost sharing agreement with the Puslinch Tennis Club in 2019.


