RECOMMENDATIONS

That staff report JRY-2024-004 regarding the Boreham Park sub-committee be received for information; and,

Purpose

The purpose of this report is to provide the Joint Youth and Recreation Advisory Committee with information on Council's direction with regards to connecting with Green Legacy to explore planting additional trees at Boreham Park.

Background

At the October 26, 2023 Council Meeting, the Council discussed the resolved as follows:

Resolution No. 2023-351: Moved by Councillor Goyda and

Seconded by Councillor Bailey

That Council endorses staff's recommendations to include landscaping to delineate the playground at Boreham Park from the ditch line at a cost of \$2.5K to be incorporated into the Boreham Park construction project; and,

That Council request the Recreation Advisory Committee and Youth Advisory Committee to connect with Green Legacy to investigate the opportunity to plant additional trees at Boreham Park and that public feedback be sought prior to proceeding with plantings.

CARRIED.

At the January 16, 2024 Joint Recreation and Youth Advisory Committee Meeting the Joint Committee endorsed the amended action plan as follows:

- 1. Sub-committee work to develop a public feedback plan.
- 2. Sub-committee to contact the Grand River Conservation Authority seeking their recommendation on the type of trees and location of trees in Boreham Park
- 3. Sub-committee to contact Green Legacy regarding procurement of trees.
- 4. Letters be sent to residents around Boreham Park regarding the feedback opportunity.
- 5. Sub-committee report back to joint Committee at the May 6, 2024 meeting with feedback and provide recommendation to Council at that meeting.

Comments

Tree orders through Green Legacy open in October 2024 for Spring 2025 distribution. Tree deliveries occur throughout April 2025. The 2024 tree species are included below. There is no confirmation that these will be the types of trees that will be available for this upcoming year.
