## SCHEDULE 'A'

### CLASSES OF PERMITS AND PERMIT FEES

- 1.1 Fees for a permit shall be in accordance with Schedule 'E' of the User Fees and Charges By-law, available at [Puslinch.ca/By-laws](http://Puslinch.ca/By-laws). **Minimum Fee \$181.00.**
- 1.2 Where the fees are based on the cost of valuation of the proposed work, such cost or valuation shall mean the total cost of all work regulated by the permit and without restricting the generality of the foregoing, shall include the cost of all material, labour, equipment, overhead and professional and related services.
- 1.3 Permit fees are required to be paid at time of application.
- 1.4 The Chief Building Official may place a valuation on the cost of work and the permit applicant shall pay the prescribed fee(s) before the issuance of the permit.
