Addition to the Agenda Questions received from Council seeking additional information and the corresponding responses provided by staff regarding the November 6, 2024 Council agenda items.

6.6 Town of Petawawa Council resolution regarding Ontario Provincial Police Costs 2025
-given that we contribute funds to the County for policing which is done by contract, would it still make sense to support this motion?

6.7 Whitewater Region Council resolution regarding Ontario Provincial Police Costs 2025
-as per 6.6

Council has not previously passed a support resolution with respect to recommendations that the Provincial Government reabsorb the costs associated with the Ontario Provincial Police. As the support resolution is related to re-absorbing the costs of small municipalities that do not have contracts with Ontario Provincial Police, this support resolution is not relevant to the Township.

6.9 Mill Creek Pit #5738 - Monthly Monitoring Report - September 2024

Did we asked staff to inform GRCA regarding the beaver dam at a previous Council meeting. If so any outcome?

At the September 25th, 2024 Council Meeting Mayor Seeley stated that he had contacted the GRCA regarding this beaver dam and advised that the dam is located on private property and that the property owner will not provide access. The Mayor also spoke with Dufferin Aggregates to see if there is potential to get access to the dam from their side and it would be very challenging. The GRCA does not look after the micro-flooding caused by a beaver dam and relocating beavers is not something they manage. Further, Councillor Goyda advised she would bring it up with the Mill Creek Stewards.

7.2.1 10:30 A.M. Delegation by Bruce Joy, President of Puslinch Minor Soccer regarding an update on soccer and facilities

-how much does a shipping container with lighting and ventilation cost of the size to replace the burned building compared to a replacement building? **The Township's Zoning By-law has**



prohibitions related to shipping containers, and therefore this is not a viable option to replace the shed. Staff have obtained a quote to replace the shed utilizing the existing concrete pad, adding metal siding and metal roof. The quote is \$18,000.

9.2 Finance Department

9.2.1 Report FIN-2024-028 - 2025 User Fees and Charges By-law

-can an option be that staff contact the Aberfoyle Market to see if they would be willing to sell the posters on our behalf at the current rate with a Commission of say \$5 to the vendor per poster? We could still offer the poster to residents for \$10. **Staff can inquire with the Aberfoyle Antique Market and report back to Council.**

9.3 Administration Department

9.3.1 Report ADM-2024-052 Senior Advisory Committee#

-p. 69 what is the rationale for two senior members; why not 3 to balance the committee membership? **The current Committee composition is 5 voting members (including the chair), adding 3 new members would increase the composition to 8 voting members. Staff prefer to avoid even numbered membership as all tied votes are lost (in accordance with the Township Procedural By-law). The TOR could be clarified to state that at least 2 members are 65 years of age or older. This would give Council the ability to be flexible with the Committee composition based on interest in the next term. For the remainder of this term, unless current members vacate their seat, 2 senior members could be added.**
