Purpose

The purpose of this report is to provide the Recreation and Community Wellness Advisory Committee with an update on its goals and objectives for the 2022-2026 Term.

Background

In accordance with the Committee's Terms of Reference, Committees may have a maximum of two active goals or objectives at any given time. Goals and objectives can be added to the Committee's workplan as follows with priority given to goals and objectives referred by Council.

- A committee member or sub-committee can prepare a proposal, which is then presented to the Committee for endorsement then subsequently presented to Council for their approval; or
- Council referring a goal or objective to the Committee.

Comments

The Committee's workplan is attached as Schedule A to this report. This workplan is a living document and includes active, inactive, draft proposals and completed projects.

Below is an update for each of the approved goal or objectives for 2025.

Active Goal/Objectives

1. Community Liaison Sub-Committee

This sub-committee was formally re-established at the September 16th Recreation and Community Wellness Committee meeting with sub-committee members being Mary Christidis, Joanna Jefferson, and Stephanie McCrone. This sub-committee is to act in a general capacity to liaise with community groups on Township initiatives.

2. Senior's Drop-in Programming

At the October 8, 2025 Council meeting, Council approved the one year Senior's Drop-in Pilot Program. The sub-committee members are Margaret Hauwert, Tracey McQueen, and Beth Charles.

Staff have reserved the Alf Hales Room every Thursdays from 1:00 p.m. to 2:30 p.m. through Thursday October 18, 2026. Programming examples include cards, board games, crochet/knitting, book club, trivia, jigsaw puzzles, or any wellness activity that does not require an instructor, incur additional costs, or exceed the limitations of the facility space. Responsibilities of the Seniors Drop-in Programming sub-committee for the duration of this pilot project will include:

- Managing the program schedule
- Coordinating advertising initiatives with Township staff
- Attend the drop-in program to track participation and collect feedback
- Notifying staff when attendance levels are high

Staff are seeking feedback from the sub-committee during regularly scheduled Recreation and Community Wellness Advisory Committee meetings on how the program is operating.

Recreation programming initiatives such as Zumba or line dancing will be incorporated in the Recreation and Parks Master Plan review as this type of programming requires further resources including but not limited to registration software, insurance requirements, RFP process for instructors, etc.
